KEY DOCTRINES OF THE FAITH

- 1. We believe that the Bible is God's Holy Word, without error, and is the sole authority for faith and life.
- 2. We believe that there is one God: the Father, the Son and the Holy Spirit. They subsist in unity, and also as three separate, distinct Persons all equally God. God has always existed, and He is the creator of the universe.
- 3. We believe that Jesus Christ is God's Son. He was born of a virgin as both fully God and fully man, lived a sinless life, died to atone for the sins of human beings, was buried, arose from the grave, ascended into heaven and will literally return to earth. He is the only way to God.
